(Annexure - A (Colly) and Annexure B Enclosed) A CD was also provided with the Sexually Explicit Screen Shots and Recordings of the same from HotStar of these highly sexually explicit and lascivious programs /contents and the various screen shots taken of the same. Annexure - C Despite legal prohibitions, M/s Novi Digital Entertainment Pvt. Ltd and Star India Pvt. Ltd openly violates the concerned laws which has already caused severe damage to the society and is likely to lead to more serious consequences due to easy and ready access to digital media. Due to this, especially young and adolescent children who have easy and unrestricted access to smart phones, tablets, laptops, IPTV Set Top Boxes and Internet connections have become more vulnerable of being exploited by dissemination / broadcasting of obscene and sexually explicit content. Moreover, the rising number of crime rate in rape cases also calls for preventive measures to the activities such as this. A great concern from the Women Representative Groups also have been raised as these programs contains indecent representation of women and portrays women in poor light such as prostitution and un-consensual intercourse. This illegal HotStar IPTV service being run by Novi Digital Entertainment Private Limited and Star India Private Limited portray women in very poor light and also promotes homosexuality, unnatural sex, group sex, prostitution etc. and are punishable under various Sections of the IPC, like Section 292, 293 of Indian Penal Code, The Indecent Representation of Women (PROHIBITION) Act 1986 and Section 67 A of Information Technology Act 2000. Considering the above, it is expedient that an immediate legal action. with a FIR be lodged under applicable sections of laws and an action be taken against this illegal IPTV service HotStar and the principal officers/ CEOs named of M/s. Novi Digital Entertainment Private Limited and M/s. Star India Private Limited both having their registered offices at : STAR HOUSE, URMI ESTATE, 95 GANPATRAO KADAM MARG, LOWER PAREL, (W) MUMBAI - 400013.
